The preschool teacher work closely with the building teachers and PAT coordinator. A kindergarten screening is held along with other parent involvement activities to help the children transition. The preschool programs are within the same building as the kindergarten so the students are familiar with the building. Preschool students are served breakfast daily, which helps them learn the cafeteria system. Preschool students are encouraged to attend summer school before they begin kindergarten.
